## BY AND BETWEEN THE PARTIES

**Mihir Bhoj P.G. College (MBPGC)** is a Government Aided College established in 1968. The College is affiliated to Chaudhary Charan Singh University, Meerut. The college is recognized under section 2(f) and 12(B) of the UGC Act by the University Grants Commission (UGC). Permanent Campus of the College is situated at Dadri, Gautam Buddha Nagar district of Uttar Pradesh from where the college is running its academic operations.

And

**Nirbhed Foundation** is an all-India jurisdiction non-government organisation registered under societies Act-1860. Nirbhed Foundation established in 2015, is a team of young professionals (mostly working government Officers). Nirbhed Foundation imparts elementary education to Children who are economically weak and are working, school dropouts and children who never went to school. The Head office of Nirbhed Foundation is situated at plot no 668 G.F, Nearby St. Teresa School, Shakti Khand III, Indirapuram, Ghaziabad, Uttar Pradesh 201014.

For the development of joint collaboration in accordance with our mutual interests in providing practical training to the students as part of the Skill Development Course- *Social Work* (as prescribed by the CCS University, Meerut) **Mihir Bhoj P.G. College, Dadri** and **Nirbhed Foundation, Ghaziabad** mutually agree to join this Academic Alliance.

Both parties agree to exercise their best efforts to develop the following forms of cooperation:

1. To establish ties for academic cooperation specifically for the skill development course on "*Social Work*", any short-term course in the discipline of *Social Work* or extension activities.
2. To jointly organise seminars, conferences, workshops and short-term courses on the topics related to the course "*Social Work*", other courses of similar nature and collaborative extension activities with mutual agreement.
3. The Department of Political Science, Mihir Bhoj P.G. College being the nodal department to run the Skill Development Course on "*Social Work*" shall be responsible for the registration of students to the said course. The collaborative extension activities, if mutually planned, shall be coordinated by the respective department, cell, club etc.
4. The number of students registering for the course in a batch shall be ideally less than 100. However, if the situation warrants, the limit may be extended.
5. It shall be the duty of Nirbhed Foundation to provide online/offline practical training (free of cost)/ field work/case study as prescribed in the course to the students registered in the course.
6. Nirbhed Foundation shall be responsible for the evaluation of students on the basis of their overall performance in practical training and also provide the students with the certificates for the same.
7. The certificates shall be sent to the Department of Political Science, Mihir Bhoj P.G. College, Dadri through the medium mutually agreed upon.

9. There shall be no financial liability, in whatsoever manner, between both the parties.

The agreement will provide logistics and management details appropriate to the successful operation of the programme. The agreement will fulfil the spirit and purpose of this general Academic Alliance. The operational details regarding implementation of the agreement shall be finalised with mutual consent.

#### **DURATION and TERMINATION**

This Academic Alliance shall commence on its date of execution by the Parties and will be terminated:

(a) after 3 years; or

(b) at any time for convenience by either party with 30 days' written notice; or

whichever of the above occurs earlier.

Notwithstanding this understanding, the Academic Alliance may be subject to modification or revision by mutual written agreement.

No party can assign this agreement to any other party without the consent of each other.

## **NOTICE**

Any notice, approval, consent, request or other communication required or permitted to be given or made under this Academic Alliance will be in

### **SEVERABILITY**

This duty shall survive even after the termination of this Academic Alliance for next 3 years after the expiry of this Academic Alliance on mutual consent.







### **AGREEMENT**
